» Align Plans with the Funding Priorities and Criteria. At the core of any successful grant or funding application is a plan that is visionary and practical that clearly demonstrates need and the viability of the project within the community. » Validate Project Feasibility—Supporting Documents and Studies. While many grants do not specifically require supporting documentation, agencies are more willing to fund a project that has proven need and support through supplemental data and studies. To meet the grant-specific guidelines, applicants must often prepare technically complex feasibility reports, environmental reviews, financing plans, robust economic analyses, and proof of public support. Having this requisite technical data can demonstrate project readiness and improve the likelihood of success.

## U.S. DOT TIGER Discretionary Grant Funding Experience

#### Pawtucket/Central Falls Commuter Rail Station, Pawtucket, RI

Working with RIDOT, VHB helped to identify the eligible project and supported the TIGER grant application effort, then went on to lead the planning, permitting, and design through final delivery of RIDOT's \$13M Pawtucket/Central Falls Commuter Rail Station. The new station improved infrastructure along Amtrak's Northeast Corridor and provided a new intermodal connection between commuter rail and local bus service.



#### Fast Track New Bedford TIGER Grant Application, New Bedford, MA

VHB assisted MassDOT in the development of a successful \$20 million TIGER Grant application for the reconstruction of three rail bridges vital to the creation of a commuter rail connection to southern Massachusetts. VHB provided assistance with the grant application writing and compilation, including cost estimates and benefitcost analysis of the rail project.
